## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) has been made and executed at Lucknow on this 12<sup>th</sup> day of December 2022 between Babu Banarasi Das College of Dental Sciences, BBD University, Faizabad Road, Lucknow-UP- 226028, India (State Private University and UGC approved) of the one part and Hind Institute of Medical Sciences, Safedabad, Barabanki, UP-225003, India (Self financing private medical college and hospital, recognized by NMC) of the second part.

#### 1. COMMENCEMENT AND DURATION

This Memorandum of Understanding (MOU) shall be effective from the date of signing and shall continue for a period of 1 year. The Memorandum of Understanding (MOU) may be extended by mutual consent for a further period as decided by both parties.

### 2. OBJECTIVE

To offer clinical and theory training for 3<sup>rd</sup> yr. B.D.S. students in the subject of General Medicine and General Surgery and M.D.S. students in Head and Neck oncology and allied medical subjects as per Dental Council of India norms.

#### 3. BROAD AREAS OF COOPERATION

- **3.1** BBDCODS, Lucknow and HIMS, Barabanki have intended ,agreed and consented to the following terms in pursuance of the clinical and theory training for 3<sup>rd</sup> year B.D.S. and M.D.S. students.
- **3.2** HIMS shall provide the theory and clinical training to 3<sup>rd</sup> yr. B.D.S. students in the subjects of General Medicine and General Surgery and M.D.S. students in Head and Neck oncology and allied medical subjects through the faculty members of the respective departments.
- **3.3** During the theory and clinical training, students of BBDCODS will follow all rules of discipline and conduct as assigned by the competent authorities of HIMS.

#### 4. FEE

- **4.1** HIMS will charge Rs. 10,000/- per student as clinical training and practical examination fee vide Demand Draft in favour of "Managing Director, Hind Institute of Medical Sciences".
- **4.2** The fee shall be deposited prior to commencement of the clinical training of the particular batch of students.
- **4.3** The training and practical examination fee once deposited to HIMS will be non-refundable and non-transferable under all circumstances.

# 5. DURATION OF TRAINING AND STUDENT NUMBERS

- 5.1 The duration of the theory and clinical training will be for one (1) academic year.
- **5.2** The students will be posted as per the division of batches given by BBDCODS

5.3 The competent authority of BBDCODS shall prepare the student batches (Time-Table) and inform the names of the students for theory and clinical training through a letter and Email to the Principal, HIMS, at least 15 days in advance. Only those students will be permitted for training whose names are mentioned in the list provided by the competent authority of BBDCODS.

#### 6. LEGAL BINDING

- 6.1 No amendments or modification of this MOU shall be valid unless the same is made in written by all the parties or their authorized representatives and specifically stating the amendment to the MOU. The modification shall be effective from the date on which they are made, unless otherwise agreed to.
- 6.2 No party shall use, nor permit any person or entity to use the name or logo (or any variation thereof) of another party without obtaining prior written consent from the other party. Both parties shall do their utmost to ensure the smooth and efficient implementation of the MOU and the training programs.
- 6.3 This MOU can be terminated by either party by providing 60 (Sixty days) notice of termination. However, the termination shall not be during the academic session and should not adversely interrupt or impair the training program or course of study of the students as commenced prior to such termination.
- 6.4 Any differences or disputes between the parties concerning the interpretation and / or implementation and / or application of any of the provisions of this Memorandum of Understanding (MOU) shall be jointly settled amicably through mutual consultation and or negotiations between the parties without reference to any third party, tribunal or court of law.
